Legal framework (1): Why do we want International Cotutelles (joint International supervision)?

Verification and accreditation of Doctoral Programs (art. 10 RD 99/2011). Criteria for verification and accreditation of Doctoral Programmes shall evaluate the internationalisation degree of such Programmes, giving special attention to:



International professors and students.

Mobility of professors and students.

Outcomes such as Cotutelles.

Legal framework (2): what does it take to have an **International Cotutelle?**

Requirements for PhD theses under an International Cotutelle Regime (art. 15 RD 99/2011):

a) The theses must be supervised by 2 or more Doctors from 2 Universities, one from Spain, the other from abroad (maximum 3 Thesis Directors).

Must formalize a Cotutelle Agreement.

b) During formation period, PhD Student must spend at least 6 months at the partner University.

> Stages and activities must be envisaged at the Cotutelle Agreement.

Main steps (1): deploying a Cotutelle

Basic guidelines of the Cotutelle with the Partner University must be set, bearing in mind:

Period to be spent at each University.

Minimum of 6 months at each University is mandatory.

Payments.

Administrative fees must be paid each year to the UAB, regardless of what is obliged by the Partner University.

Language of the thesis.

Both writing and defence of the thesis must be in one of the languages accepted by the University where the thesis is defended. It must be accompanied by a summary in one of the languages accepted by the other University.

Main steps (2): deploying a Cotutelle

Composition of the **Examining Board**.

Between 3 and 8 members with 2 or 3 reserves. Most of the panel members should be external to both universities. The supervisors may only form part of Examining Board composed by 5 or more members.

Place of defence of the thesis.

It must be agreed whether this will take place at UAB or the partner university.

Approval of the application by the Permanent Board.

Signing process of the Agreement through the Doctoral Studies Administration Office can be started.

Defending the thesis under International Cotutelle regime

Defence takes place at the UAB:

1) The composition of the thesis Examining Board is determined by the cooperation agreement signed between the UAB and the Partner University.

2) After the defence, two reports are signed: one for the UAB and the other for the Partner University.

Defence takes place at the Partner University UAB:

1) candidate must have been admitted to a PhD programme, paid the registration fees, and registered the thesis project on the corresponding PhD programme.

2) candidate must register the thesis at the Doctoral School of UAB.

3) The thesis examining board must comply with the provisions of the Cooperation Agreement.

4) UAB must be given notice of the date, place and time of the defence by the Department in charge, with sufficient time to make this information public.


